The records on these will only include the image title, your name and scores awarded.
2. If you submit an image to the club for display on the Club's website or Facebook page, or for release to the press, you will be consenting to public display of your name and image.
3. All personal data the Club holds on you will be securely stored.
4. Your personal data will be accessible to you and the members of the Club's committee. If you agree to your email address being shared with other members of the club, please tick the box on the membership form. Only your email address will be accessible to club members.
5. The data you share with the Club will be used solely for club business and the sharing of relevant information on photography. Information shared by members, using the list of club members' email addresses, must also comply with this condition.
6. Your personal data will not be made available to any third party, shared with anyone else or used for any form of marketing, except as specified on the club's Data Privacy Policy document.
7. You have a right of access to know what personal data the Club currently holds on you and you have a right of rectification to correct errors or update data held on you.
8. You have a right of erasure to have some, or all of the personal data held on you deleted from the Club's records.

9. The Club undertakes to remove personal data immediately upon written request from you, or within one year of a member cancelling their membership.
